1.0. Availability of Bid Document and Bid Submission

The Bid documents shall be available in Office of the Notified Area council, BELLAGUNTHA with effect from 20.11.2023 11.00 AM to 06.12.2023 up to 11.00 AM

The entire bid-submission would submissions are as follows:

- Technical Bid of the Tender Document
- Financial Bid of the Tender Document
- Both technical bid and financial bid to be submitted offline, through Registered Post
 / Speed Post / by hand on or before the specified due date.

1.01. Submission of Documents by bidder

The Bidder shall submit following document also.

- Technical Qualification Documents in original as mentioned in "Clause Bidding Document"
- Originals of EMD, Tender Document fee in the form of money receipt/DD etc.

1.02 Tender Fee

The Tender Fee Deposit as mentioned in NIT and shall also be submitted in physical form in courtesy of Executive Officer, BELLAGUNTHA Executive Officer payable at BELLAGUNTHA.

The Tender Fee is accepted only in the following forms:

- Banker's cheque of a Nationalized Bank / Scheduled Commercial Bank (i.e., Public and Private Sector Banks).
- Demand Draft of a Nationalized Bank / Scheduled Commercial Bank
- Money receipt obtained from office after depositing the requisite fees.
- 1.03 All the quotation found genuine after opening should remain valid for a period of 90 days from the date of opening of the quotation.
 - Agreement in prescribed form of Notified Area Council, Belaguntha. is to be drawn by the successful Bidder.
 - If any excess payment made to the supplier / auth. Dealer is detected at any stage or is pointed by audit for recovery, then the same shall be recovered from the supplier/ auth. dealer.
 - In case of dispute or selection, Executive officer's decision is final and binding on the Supplier/auth. dealer.
 - The quotation conditions will be treated as conditions of the contract whether If he or they are not enclosed to the contract documents.
 - The materials and work will be inspected by the Engineer-in-Charge or any other person duly authorized by him from time to time. It is the duty of the supplier / dealer to remove all rejected materials from the site within 24 hours at his own risk and cost. If

necessary, the supplier /auth. dealer should produce test certificates of the raw materials and finished products at his cost.

- The cost of materials shall be inclusive of all taxes and duties. No further claim in this regard will be acceptable to this office. Deduction of taxes during payment will be made as per rules.
- The rates shall be form for the contract period. The supplier /auth. dealer will not be covered under price escalation clauses.
- Penalty clauses and all other terms and conditions (up to date and as applicable) as per OPWD code of practice.
- All the quotation should be filled up and sign the Declaration Certificate attached herewith and submit the same along with the Quotation papers.
- In case of failure of the successful bidder to comply with the agreement terms and conditions and any written instructions with respect to time of delivery, 'quality of materials, replacement or repair of materials/ works within the stipulated period to the full satisfaction of the Engineer-in-Charge, then it will be treated as a breach of contract and hence the agreement will be liable for termination / rescind immediately and a formal intimation to that effect by this office will be binding on the supplier. In such a situation, this office will be at liberty to adopt any policy of procedure so as to ensure completion of the work. The quotationer should submit their offer in the tender papers only prescribed by this office.
- Payment will be released in favors of the successful bidder after completion of the work subject to availability of funds and technical verification and satisfaction by Engineer in-Charge. No claim or subsidiary claims in any manner for any reason whatsoever by the supplier will be acceptable to this office. Delay in execution of the work by the supplier on the ground of non-payment will be a just and sufficient example of violation of the condition of contract and in such situation, action as deemed fit will follow. Running Account Bills will not be preferred ordinarily. In exceptional circumstances, the same may be considered. Photographs for the work at various stages (prior to execution, during and after completion) shall be taken by the supplier /auth. dealer from various positions for the work as per instruction of JE and should be submitted at least in quadruplicate before preparation of the bill for the work. Similarly, project description board should be erected/installed at suitable locations as per direction of Engineer-in-Charge. This office will not consider extra payment to the supplier / auth. dealer tor photographs and the board.
- As security deposit, 3% of the gross running account bill amount will be recovered from payment bills, which will be released after L. F.S. Audit checking subject to no recovery detected by them. In case of any recovery found from the supplier as pointed out by the L.F.S. Audit or any other authorities/ agencies, the action as appropriate will be taken to recovery the same from the supplier of any amount as per prevailing rules.

However, relaxation/waiving would be availed after producing the relevant documents.

- The schedule of execution as directed by Engineer-in-Charge shall be followed by the supplier / auth. dealer and for this no claim whatsoever will be entertained at any time.
- The quantities and items as mentioned in the quotation are approximate and subject to change at the time of execution or ordered if required under the written orders of the Executive officer.
- The work should be completed within the prescribed time of completion from the date of issue of work order failing which penalty will be levied as per rule. Extension of time will be not allowed under any circumstance.

• The Engineer-in-Charge has authority to make any alteration or addition to the original specifications. The supplier/ auth. dealer has to obey the drawing, design and instructions that may be given to him as and when necessary, during progress of the work. The supplier /auth. dealer shall be bound to carry out the work in accordance with the instructions.

1.04 Qualification of the Bidder: -

- The Bidder should be having updated PAN, GST clearance and credentials of execution of such projects.
- The Bidder should have an average Financial Year Turn-Over of minimum INR 01crore of last 3 Years. The FY Audited Reports should be submitted.
 However, the Bidders with Start Up India along with Startup Odisha along with MSME with UDYAM status are relaxed and should have minimum INR 10 Lacs of last 3 Years. The FY Audited Reports should be submitted.
- The Bidder should have previous Experience in installing and Commissioning of IT Enabled, Module LED Acrylic supported by SMPS for the Day and Night Illuminated Large Digital Graphics, LED Acrylic Digital Entry /Exit Gates of or for any Govt./PSU sectors.
- The bidder should have the credentials of Complete design, consulting and successful Installation and commissioning of large IT enabled digital graphics which should include civil foundation, mechanical/ structural fabrication and then convert it to IT enabled digital graphics of any Organization. Bidder shall submit Completion Certificate/Word order of Such Projects.
- The Bidder should have the Local Office with all the required Manpower available to support extensively and 2 of their Engineers to attend the services regularly for at least 12 months after successful completion of the Project.
- The Bidder should have successful Track Records, should not be Blacklisted in any of the Govt./PSU sectors.
- The Bidder should submit their best 2D and 3D design and required Layouts for the Technical Evaluation and Comparison.
- The Bidder should obtain the Site Visit Certificate from the Junior Engineer, NAC Belaguntha.

1.2 BIDDING DOCUMENT

- 1.21 The bidder is expected to examine all the documents prior to preparation and submission of bid.
- 1.22 The bidder is advised to visit the site at his own expenses to assess the accessibility, climate and other conditions of the area etc. before quoting the rates. No claim shall be entertained later, on any such account.
- 1.23 Failure to comply with the requirements of bid submission will be at bidders" risk and shall be considered as non-responsive.
- 1.24 The intending bidders must read the terms & conditions of tender documents carefully. They should only submit the bid if they consider themselves eligible and they are in possession of all the documents required.
- 1.3 The Bidder shall submit Technical Document along with the Bid Documents.

The offline submissions as mentioned above shall be submitted on BELLAGUNTHA NAC address mentioned in NIT as per date and time mentioned in NIT otherwise bids are liable to be rejected.

1.4 Contents of Financial Bid

The Financial Bid should be submitted along with Technical Bid, before last date and time of submission of Bidding Document.

The estimated cost mentioned in NIT is based on the estimate based on the scope of work of the project and also based on DSR provisions and Non-scheduled items as per the standard practice. The bidder shall quote keeping in view all associated costs with the project including any out of pocket / mobilization expenses / Custom duty (if any), Buildings and Other Construction Workers Welfare Cess, TDS, taxes (except GST) if any applicable as per Govt. terms, shall be paid by the Agency. **The Goods and Services Tax (GST) shall be paid extra over quoted cost to Agency.**

It is mandatory to bidders to deposit GST within time limit framed by Govt. of India, if applicable. The Goods and Services Tax (GST), shall be reimbursed to the Agency only after uploading of bills by Agency on GST Portal "to avail Input benefit of GST".

The company shall be performing all its duties of deduction of TDS and other deduction on payment made to the Agency as per applicable legislation in force on the date of submission of bid or to be newly / amended introduced during the execution of the Contract.

Quoted amount by bidder shall be firm and fixed for Three (03) months. The contract may be extended, according to the direction of Project Authority, in this case the rate quoted by the bidder remains firm and no escalation shall be applicable for extension. Therefore, it is advised to Agency to quote the rate accordingly.

Note: - The BELLAGUNTHA NAC reserves the right to waive minor deviations if they do not materially affect the capability of the Tenderer to perform the contract.

1.5 Opening of financial Bid

The financial bids of the technically qualified bidders shall be opened at the notified date and time mentioned in NIT.

1.6 Joint Venture

Joint Venture / Consortium / Associations are accepted / allowed and maximum number of partners is limited to 2 (i.e., one lead + 1 JV partner).

2.0 BID PRICES

- 2.1 The bidder shall fill in rates and prices for all the items of the schedule of works. The rates should be inclusive of all applicable taxes & duties, if any, and exclusive of GST which will be paid as applicable.
- **2.2** The quoted price shall include, but not be limited to, the following activities:
 - Restricting or stopping traffic of persons and vehicles near instruments or in sightlines during instrument observations.
 - Taking all necessary safety precautions;
 - Clearing sight lines by removal of bushes and scrub.
 - Access to the project site
 - Making of temporary paths for movement of equipment etc.
 - Any stoppage of works due to any unforeseen reason.
- 2.3 The rate should include all taxes & duties, calibration, insurance, transportation etc. (excluding GST) and nothing extra will be paid over and above the contract price as specified in Annexure-A.
- 2.4 Income tax and all other taxes, levies, impositions, deductions, charges, fees and similar assessments whatsoever imposed, assessed, levied or collected by the State Government and the Government of India or any subdivision thereof or any tax authority therein upon the Agency (Successful bidder to whom the work is awarded by BELLAGUNTHA NAC) and his staff, shall be paid and/ or borne by the Bidder and BELLAGUNTHA NAC shall perform duty of deduction from payments whenever required by law.

5.0 <u>Detailed Technical Requirement</u>

Approximate size entry-exit Structures where the IT Enabled Digital Graphics need to be carried out as follows,

• Gate #1 ---- Size= 35'(Length) X 4'(Height) =01nos.
• Gate #2 --- Size= 40'(Length) X 4'(Height) =01nos
```

IT Enabled Digital Graphics Module LED of Samsung (Korea) / any other similar brand supported by SMPS, IT enabled Day & Night Illuminated Individual Acrylic Letters are expected in Acrylic LED Digital Graphics. The Letters should be of 3D with a minimum thickness 2.5 Inches and Height of at least 14" Embossing of Major Letters. "MIGRA CIPTA/ SINKOLITE" Brand design acrylic of 3 to 4 mm Thickness should be used as Front Side design. The side raising with 2" to 4" would be of Aluminum. The Entire Letters would be put on a 3mm ACP Background of City Bond or any reputed brands.

- 1. The Graphical Display will contain in "Bingyapita Anchala Parishad, Belaguntha" Logo of 3' Diameter on the left, "Swagatam" and "Dhanyabaad" in Acrylic Design Layers of Cherry Red alternative sides respectively supported by LED Acrylics of at least 14" in height of Odiya Letters. "Bingyapita Anchala Parishad, Belaguntha" in the middle of Parrot green Color designed acrylics in both sides to be placed centrally of at least 12" Height would be made up of Design Acrylics with LED supported of Odiya Letters.
- 2. There would be a 2" border of LED acrylic all around the Graphical display of red and green colour across the border of ACP Box like Structure.
- 3. Modules LED of Samsung (Korea)/Hising to be used for the individual Letters of "Swagatam", "Dhanyabaad" and "Bingyapita Anchala Parishad, Belaguntha" and for all LOGOs. All the LOGOs will be UV printed/Vinyl pasted on front side of the LED Acrylic.
- 4. The LED Acrylic graphical display of LOGOS of NAC Belaguntha at the left of both the sides of the structure, of of at least 3' diameter, will be made of Acrylic with UV / Vinyl pasted on front facing supported by LED Acrylic upon ACP on back with 2"/3" aluminum side raising of Stainless-Steel Finish. It will be fabricated with Allunminium Channel to hold it with reinforced for strength and more rigidity by the means of Welding in order to create a seamless join.
- 5. There would the Roof and Floor of the gate structure would be made up of ACP whereas the floor ceiling would be fitted with 2 green and 1 Pink designed Drop lights. There would be arrangements of Canopy External Lights to be focused on each sides of the Pillars as required.

- 6. The new Structures will be placed on top of 2 RCC Pillars which are pre-existing of Approx Size 2.5 Feet * 2.5 Feet * 20 Feet in Height.
 - The Pillars are 35 feet and 40 feet apart in Gate 1 and Gate 2 respectively.
 - Base plate at bottom would be of 16 mm MS/GI Plate thickness and 12 mm on Top of the new proposed Structure.
 - At bottom side Nuts would be of 25 mm * 8 numbers and the required Height would be of 2 feet / 3 feet as required. Ring Size would be of 12 mm Rods, 10 mm meshing on the base of 10" at bottom foundation.
 - The Dimension of Structure to be placed on top of the Poles are as follows, There would 2 Structures of 16.5 feet and 20.5 feet each would be placed with the help of Nut and Bolts and Welding Joins in order to create a seamless join among the two.
- New Structure: The Outer frame of the Structure would be made up of 2" Square GI Pipes and would be supported by 1.5" GI square pipes acting as Rib to be placed cross of Horizontal and Vertical distance of 4 feet apart of the entire Structure. Approximate weight of the Structure would be around 575 Kgs per Structure per Gate. The Structure would be of 4 feet in Height, 2 feet depth of width and 37 feet long for Gate#1 and 41 feet length of Gate#2.
- The Pre-Existing RCC Pillars of 2.5 feet * 4 Feet * 22 feet height would be ultra finish by ACP Paneling and eco-solvent Vinyl print will be put on both the pillars with the theme of any local traditional significance.
- 7. Detailed Earthing Engineering Design and Work would be carried out as required to avoid the Thunderbolts and Lighting related Damages.
- 8. Same design would be repeated and carried out for the both the gates 1 and 2.
- 9. Module SMD LED for Lighting, as per required nos. Light source: 1.5W LED lights Light color: White LED.
- 10. Power Supply→ 4 to 6 KW, External Power Supply: 220 240V AC, 50Hz, 33-amp 12V DC Water Resistant Power Supply= 15 nos.
- 11. Environment → Operating temperature: -20°C to 80°C Humidity 0 to 100% RH Pressure +/- 10%.
- 12. Free AMS of 1 Years is considered.
- 13. The physical Damage caused through Wind and other factors, The Cloud Bursting, Lighting Damages, Voltage Fluctuations and the Theft are not considered in this scope.
- 14. By looking at the Lucrativeness, Longevity and better Monitoring, the Day and Night Illuminated LED Letters is expected with a value-added 3mm ACP Background.
- 15. The night Electricity Connection will be availed by Notified Area Council, Belaguntha. of minimum 4 KW Power Single Phase Supply per gate is required.
